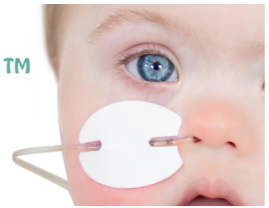

Applicant certifies that the information and statements contained herein and attached hereto are true and complete and are made for the purpose of requesting Nutri-tube™, LLC (nutri-tube™) to establish a line of credit for the Applicant. The Applicant has authority to enter into this agreement, and any person signing it on Applicant's behalf has been duly authorized to execute this agreement for Applicant.

nutri-tube™ is hereby authorized to obtain any information they may consider necessary from any source and Applicant hereby authorizes the financial institutions and companies listed above to release all necessary information to nutri-tube™. In consideration of, and in order to induce nutri-tube™ to establish a line of credit, Applicant promises to pay for all invoices within thirty (30) days of the date of the invoice (Net 30), unless agreed to otherwise in writing, and in accordance with nutri-tube™ (s) terms and conditions of sale as disclosed upon nutri-tube™ invoices. This agreement may only be modified in writing, executed by an officer of nutri-tube™.

Applicant agrees that it shall pay all of the invoice price according to the terms and failure to pay shall entitle nutri-tube™ to charge Applicant interest at the rate of one and one half percent (1.5%) per month, eighteen percent (18%) per annum. Should Applicant default in the payment of its account, nutri-tube™ shall be entitled to incur expenses for the costs of collection, including but not limited to attorney's fees and collection agency fees, which amount shall be added to unpaid balance of Applicant's account and shall be due from Applicant to nutri-tube™.

The credit terms provided by nutri-tube™ are in its sole discretion and can be terminated at any time by nutri-tube™. If at any time nutri-tube™ reasonably determines that Applicant's financial condition does not justify the continuation of nutri-tube™(s) performance, nutri-tube™, at its sole discretion, may: i) require full or partial payment in advance for the contracted goods from nutri-tube™; ii) declare the total amount owed by buyer immediately due and payable; or iii) without any notice, suspend or terminate any performance without protest or penalty from Applicant, including canceling unfulfilled orders.

Applicant agrees that all issues and disputes relating to any credit arrangement extended hereunder shall be governed by and construed in accordance with the laws of the State of Texas and subject to jurisdiction in Nueces County, Texas. In the event that any of the provisions of this agreement shall be held by a court of competent jurisdiction to be unenforceable, the remaining provisions of this agreement shall remain in full force and effect.

The provisions of above are hereby made applicable to, shall inure to the benefit of, and shall be binding on the Applicant and Applicant's heirs, executors, successors, and assigns. Credit application must be signed by an officer of the Applicant in order to be processed.

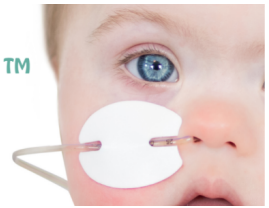
